Requirements for Abstracts:

Abstracts should deal with a relevant topic, contain in-depth research, proofread, without plagiarism.

The file name must meet the participant's last name, for example: Shevchenko_Abstracts.

The text must be designed using Microsoft Word and saved in .doc or .rtf format.

Title is in the middle (in capitals, Times New Roman № 14, bold type).

After one spacing, in the center there is full name, academic degree, rank (if any), post, department, full name of the institution where an author studies or works, city, country; Times New Roman N_2 14.

After one spacing there is a text which should meet the following requirements: A-4, all fields -2 cm, Times New Roman No 14, line spacing -1.5. References in the text are made page by page in the APA footnote mode (sample below).

Text volume is **up to 5 pages** including References.

Languages: Ukrainian, English, German, Czech, Polish, Slovak, Hungarian and Romanian.

The Organizing Committee reserves the right to reject materials that do not meet the scope and scholarly status of the conference, editorial and technical requirements, and miss deadline.
