## **Memorandum of Understanding**

between

**THE LAW AND ADMINISTRATION FACULTY  
OF WAR STUDIES UNIVERSITY, POLAND**

and

**THE FACULTY OF LAW  
OF TRNAVA UNIVERSITY IN TRNAVA, SLOVAKIA**

BETWEEN:

- (1) **THE LAW AND ADMINISTRATION FACULTY OF WAR STUDIES UNIVERSITY**, al. Av. Gen. A.Chruściela 103, 00-910 Warsaw, Poland (WSU), represented by the Dean of Faculty – dr hab. Marzena Toumi, prof. ASzWoj, acting under the authority of the Rector Commandant of WSU

and

- (2) **THE FACULTY OF LAW OF TRNAVA UNIVERSITY IN TRNAVA**, Kollárova 10, 917 01 Trnava, Slovakia (TU) represented by the Dean of Faculty – prof. JUDr mgr Andrea Olšovská, PhD.;

also herein after referred to as the Parties.

### **1. Aims**

- 1.1 The Parties wish to explore further opportunities for collaboration in teaching and research. The aim of this Memorandum is to provide a framework within which the Parties will seek to develop a long-term collaborative relationship.

### **2. Status of this Memorandum**

- 2.1 Other than paragraphs 6, this Memorandum is not intended to be and is not legally binding. If, as a result of further discussion, the Parties agree to collaborate in any of the activities anticipated in this Memorandum, the Parties shall enter into a formal and legally binding collaboration agreement, setting out the rights and obligations of each party in relation to that activity.

### 3. Areas of potential collaboration

3.1 Subject to paragraph 3.2, the Parties will explore opportunities for potential collaboration in the following areas:

- (a) exchange of information on course development and teaching methods;
- (b) exchange of staff;
- (c) development of joint research projects;
- (d) exchange of students;
- (e) preparation of joint publications.

3.2 The development of a collaborative relationship between the Parties is subject to the approval of the relevant authorities of both the WSU and TU.

### 4. Financial implications

4.1 The Memorandum has no financial consequences for either party.

### 5. Exchange of information

5.1 Each party will exchange information with the other with a view to understanding whether it would be effective and practical for the institutions to work together.

5.2 For contacts between the Parties and the implementation of the memorandum, the following is agreed:

5.3 Changes of the persons indicated in point 5.2 of the memorandum do not require a change of the memorandum, but only notification of the other Party in writing.

### 6. Duration, termination and review

6.1 This memorandum will enter into force on the date of signing by the last person representing the Parties indicated in the preamble to the memorandum and will last for a period of 3 years. It may be extended on the basis of an annex to the memorandum.

6.2 Either Party may terminate this Memorandum at any time by giving to the other not less than 3 months' notice in writing, or with immediate effect by written notice if the other Party fails to comply with its obligations under this Memorandum. Termination of this Memorandum shall be without prejudice to any other collaborative arrangement between the Parties.

6.3 The Parties shall review the operation of this Memorandum on an annual basis.

6.4 This Memorandum has been draw up in English, in four originals, two for each of Parties.
