Who Can Apply

Applicants must have a first degree in **LAW** from a recognized university or institution of higher education, or provide documentation indicating that they will earn such a first degree before enrolment in a program. Candidates must demonstrate proficiency in English.

Credits and certificate

A standard student's workload in the program European Legal Studies in the whole academic year (Full time 2 semesters – winter and summer) is granted by the number of 60 credits

Students life in Trnava

Modern Trnava is an economic, political, and cultural centre of Western Slovakia and also a university city. Despite a relatively small population, Trnava is home to three universities with various types of study disciplines. These universities attract young people from the whole Slovakia as well as foreign and exchange students. The city is thus gaining a specific status having one of the highest percentages of students in proportion to the whole population in Slovakia.



Practical informations

Cost of living

Cost of living is relatively low compared to the other Central and East European countries (€ 250 - € 300 is an average monthly living cost for students), which makes the studies a lot more affordable.

We suggest that students bring approximately this sum to cover all their basic living costs per month.

The final cost of living depends on the student's personal lifestyle.

Examples of living expenses - approximate price in Euro per month:

Visa/ Permit of Residence

Students from EU/EEA member states and Switzerland do not have to apply for a visa or a residence permit. EU students need only a valid travel document (passport) or a national identity card for their entry to Slovakia. No later than 10 working days after a student's arrival to the University of Trnava they are required to register their stay with the local Foreign Police Department (Aliens Police Department), unless the provider of accommodation (e.g. dormitory) does it instead. Students have to fill in „Form notice of the stay“. Foreign Policy is open only on Mondays (7.30 - 15.00 with lunch break 12.00 – 12.30; Wednesdays 7.30 – 12.00, 12.30-17.30; Fridays 7.30 – 12.00).

If EU citizens intend to stay in the Slovak Republic for more than three months, they must apply for a residence permit (within 30 days after the expiry of 90 days).

Non-EU Students

Students from other countries (non-EU) are required to have a valid visa for their stay in the Slovak Republic. They should apply for visa at the Slovak Embassy or Consulate in their home country at least 6 weeks prior to their departure. Students from NON EU/EEA have to register for Temporary Residence Permit at the Foreign Police Department within three working days after their arrival to Slovakia. Within 30 days upon granting Temporary Residence Permit students shall undergo a health inspection in the medical facilities dealing with tropical diseases (it costs about € 100) and are legally obliged to submit to Foreign Police Department the following:

- **Confirmation of Health Insurance valid at the territory of Slovakia for the whole period of stay**
- **Confirmation of health status not older than 30 days, confirming that the third-country student does not suffer from any disease endangering public health.**

The University Library of Trnava University in Trnava is the central library of Trnava University. It performs professional library information activities, stores and bibliographically registers qualification theses, publications of pedagogues, scientific workers and postgraduate students of Trnava University, and provides library information service to students, teachers and Trnava University employees as well as to experts. Its automated library information system DAWINCI represents an integrating element of library information system of Trnava University.
